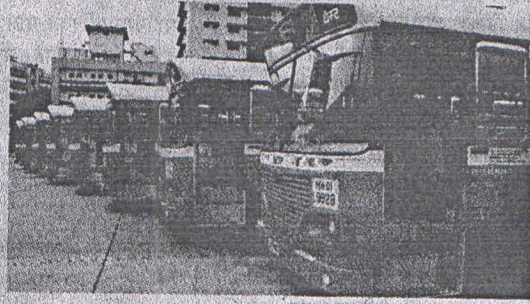

बेस्टच्या परिवहन विभागाला नवी मुंबई परिवहन सेवेमुळे प्रवासी प्रतिसाद कमी होत चालला असून यामुळे वडाळा आगार ने कळंबोली या मार्गावर चालणाऱ्या ए एस ५०३ क्रमांकाची वातानुकुलीत बससेवा बंद करण्याचा निर्णय बेस्ट प्रशासनाने घेतला आहे. हा बसमार्ग १ फेब्रुवारीपासू बंद होणार आहे. बेस्टच्या तुलनेत नवी मुंबई परिवहन विभागाच्या वातानुकुलीत बसेसचा दर्जा अतिशय उत्कृष्ट असून या सर्व बसेस व्हाॅल्वो



कंपनीच्या आहेत. तर बेस्टच्या वातानुकुलीत बस या चिनी बनावटीच्या असल्याने त्यांचा दर्जा अतिशय निकृष्ट आहे. सध्या नवी मुंबईच्या बस क्र. १०५ वांद्रे ते सीबीडी, २१२ (ताडदेव ते घणसोली) व १०८ मंत्रालय ते नेरळ

अशा दोन साध्या बससेवा कार्यरत आहेत. तर एकमेव वातानुकुलीत ए एस ५०३ क्रमांकाची वातानुकुलीत बससेवा अत्यल्प प्रवासी प्रतिसाद लाभल्याने बंद करण्याची नामुष्की बेस्ट प्रशासनावर आली आहे. दरम्यान, बेस्ट बसेसच्या तिकीट दरापेक्षा नवी मुंबई परिवहन सेवेच्या बसेसचे तिकीट दर कमी असून फेब्रुवारी व एप्रिलमध्ये दोनदा बसभाडे झाल्यावर यातील फरक अधिकच वाढणार असल्याने भविष्यात नवी मुंबईतील बेस्ट बससेवा बंद करण्याची पाळी बेस्टवर येण्याची शक्यता आहे.

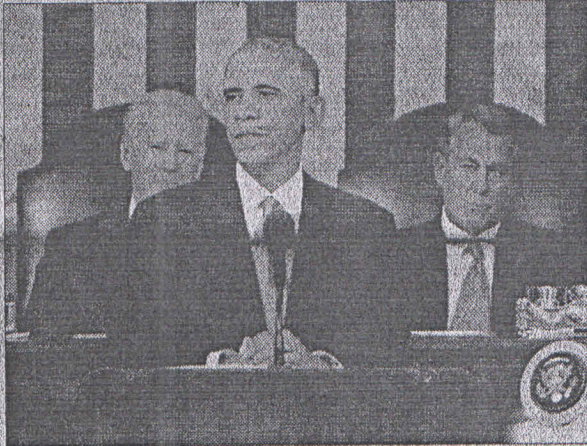
# Defiant Obama pushes 'middle-class economics'

Washington, Jan 21: President Barack Obama struck a defiant tone for his dealings with the new Republican-led Congress on Tuesday, calling on his opponents to raise taxes on the rich and threatening to veto legislation that would challenge his key decisions.

Dogged by an ailing economy since the start of his presidency six years ago, Obama appeared before a joint session of Congress for his State of the Union speech in a confident mood, buoyed by an economic revival that has trimmed the jobless rate to 5.6% and eager to use this as a mandate.

It is now time, he told lawmakers and millions watching on television, to "turn the page" from recession and war and work together to boost those middle-class Americans who have been left behind. But by calling for higher taxes that Republicans are unlikely to approve and chiding those who suggest climate change is not real, Obama set a confrontational tone for his final two years in office.

He vowed to veto any Republican effort to roll back his signature healthcare law and his unilateral loosening of immigration policy. Any attempt to increase sanctions on Iran while negotiations with Tehran over its nuclear program are still under way would also be rejected, he said. In sum, Obama appeared liberated no longer having to face American voters again after his election vic-



tories in 2008 and 2012, a point that he reminded Republicans about. "I have no more campaigns to run," Obama said. When a smattering of applause rose from Republicans at that prospect, headed with a tight smile: "I know because I won both of them."

Addressing Congress for the first time since Republicans seized the Senate in November elections, the Democratic president made clear he will not back down from his political opponents, urging

them to work with him to engage in a debate about the future "without demonizing each other."

"Imagine if we broke out of these tired old patterns," he said. "Imagine if we did something different."

The core of Obama's plan to boost the middle class is to raise taxes on the wealthiest Americans by \$320 billion over the next 10 years to pay for ex-

panded tax credits and educational benefits for the middle class, including two years of free community college.

Many of the proposals he outlined, while popular with many Americans, are unlikely to become reality, given Republican opposition and the fact Obama will soon become a lame duck as the country turns its attention to the 2016 campaign to succeed him.

But even if Obama's wealth redistribution proposals are anathema to Republicans, they could be forced to consider alternative ways to tackle income inequality and prove they can govern, which could be a factor for Americans as they consider whether to elect a Republican as president in 2016. And his moves could give an assist to Secretary of State Hillary Clinton, the overwhelming favorite for the Democratic presidential nomination if she decides to run.
